Keynote Speaker

Chief Justice Tani Cantil-Sakauye is the first Asian-Filipina American and the second woman Chief Justice. She served for more than 20 years on California appellate and trial courts, both municipal and superior. In 1997, she established and presided over the first court in Sacramento dedicated solely to domestic violence issues. and was a member of the presiding judge's task force on domestic violence. She was appointed to the Court of Appeal, Third Appellate District in 2005. She was also a member of the California Commission for Impartial Courts, and served as a member of the Judicial Council's Domestic Violence Practice and Procedure Task Force, chairing its Best Practices Domestic Violence subcommittee. She is president of the Anthony M. Kennedy American Inn of Court, an organization dedicated to promoting civility, ethics, and professionalism in the practice of law. Since 2007, she has been a Special Master, selected by the Supreme Court to hear disciplinary proceedings before the Commission on Judicial Performance.
